SPECIAL BOND ELECTION

May 21, 2024

SHALL THE BOARD OF TRUSTEES OF SCHOOL DISTRICT NO. 121 BE AUTHORIZED TO ISSUE GENERAL OBLIGATION SCHOOL BONDS OF THE DISTRICT IN A PRINCIPAL AMOUNT NOT TO EXCEED \$9,000,000, TO BECOME DUE IN SUCH INSTALLMENTS AS MAY BE FIXED BY THE BOARD OF TRUSTEES, FOR A TERM NOT TO EXCEED TWENTY (20) YEARS, FOR THE PURPOSE OF FINANCING THE CONSTRUCTION OF A VOCATIONAL TECHNICAL FACILITY AND FACILITY REPAIR PROJECTS AT THE EXISTING K-12 FACILITY, ALL AS PROVIDED IN THE RESOLUTION OF THE BOARD OF TRUSTEES ADOPTED ON MARCH 11, 2024?

The bonds will be used to provide funding for the construction of a new vocational technical facility with equipment and furnishings and for facility repair projects at the existing K-12 facility. The interest rate anticipated on the proposed bonds is 3.75% per annum. The District has no existing indebtedness. The total amount of debt to be repaid over the life of the proposed bonds, principal and interest, based on the anticipated interest rate, is estimated to be \$12,953,178, consisting of \$9,000,000 in principal and \$3,953,178 of interest. The term of the bonds will not exceed twenty years.

The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$229 per \$100,000 of taxable assessed value based on current conditions. Currently, the District does not collect a bond levy.
